a) Jewellery-waxed-beads, imitation pearls

Fashion jewellery components - waxed (imitation) pearls and beads, ie the glass base which is color-surface treated by so-called waxing (dipping technology).

a) One-component-resin, ENT (Estrela Nano Technology) coated beads

Fashion jewellery components - ENT surface coated pearls and beads, ie the glass base which is color-surface treated by one-component-resin technology.

Due to the raw material used and the technology of hand-made production, small irregularities on the surface of the pearls and tolerances in the shade of individual colors are allowed.

In the case of the technology of dipping of the loose beads small collars and peeled rings around the holes may appear.

These deviations are not to be considered as quality defects.

Damage may appear after exposing the beads to chemicals, excessive heat, hot water or abrasive friction.

Estrella Es - Press, s.r.o. representatives hereby declare that the quality of our products is of our highest importance and that we follow strict quality policy to assure customer's satisfaction.

Our products are tested in accordance with standards for jewellery-waxed beads.

Every new decor subject to testing period before its release to the market and we perform quality control at regular intervals thereafter.

All employees of Estrella Es - Press, s.r.o. are instructed to follow the given production procedure unconditionally and hereby to avoid deterioration of quality by negligence during the production process.

Alongside with above written the character of production as well as the price level of our products does not allow to provide complex quality control of each produced batch.

We issue basic output quality control that occasionally cannot determine all of possible defects, especially those which show after some time of use of the product.

The hand made production of jewellery-waxed beads is a complex process composed by many different steps which involve participation of many workers.

Therefore, potential defects may be caused by an individual's mistake during the production process as well as rarely a modification of attributes of material that is supplied to us (such as raw glass bases and chemical components to be used for colour coating).
